2. HAZARDS IDENTIFICATION

- The product is not classified as dangerous according to Directive 1999/45/EC and its amendments.
- **Classification:** Not classified.

3. COMPOSITION/INFORMATION ON INGREDIENTS

- **Substance/preparation:** Preparation of synthetic oils and additives.
- **Hazardous ingredients:** There are no ingredients present which, within the current knowledge of the supplier and in the concentrations applicable, are classified as hazardous to health or the environment and hence require reporting in this section.

4. FIRST AID MEASURES

- **Inhalation:** Move exposed person to fresh air. Keep person warm and at rest. If not breathing, if breathing is irregular or if respiratory arrest occurs, provide artificial respiration or oxygen by trained personnel. Obtain medical attention if symptoms occur.
- **Ingestion:** Wash out mouth with water. Move exposed person to fresh air. Keep person warm and at rest. If material has been swallowed and the exposed person is conscious, give small quantities of water to drink. Do not induce vomiting unless directed to do so by medical personnel. Obtain medical attention if symptoms occur.
- **Skin contact:** Flush contaminated skin with plenty of water. Remove contaminated clothing and shoes. Obtain medical attention if symptoms occur.
- **Eye contact:** Immediately flush eyes with plenty of water, occasionally lifting the upper and lower eyelids. Check for and remove any contact lenses. Continue to rinse for at least 10 minutes. Get medical attention if irritation occurs.
- **Protection of first-aiders:** No action shall be taken involving any personal risk or without

training.

- **Notes to physician:** No specific treatment. Treat symptomatically. Contact poison treatment specialist immediately if large quantities have been ingested or inhaled.

5. FIRE-FIGHTING MEASURES

- **Extinguishing media:**
Suitable: Carbon dioxide (CO₂), Foam, Powder.
Not suitable: Do not use a jet of water.
- **Special exposure hazards:** No specific fire or explosion hazard. Promptly isolate the scene by removing all persons from the vicinity of the incident if there is a fire. No action shall be taken involving any personal risk or without suitable training.
- **Products of combustion/thermal decomposition:** Carbon oxides (CO, CO₂), nitrogen oxides (NO_x), smoke and irritating vapours as products of incomplete combustion.
- **Special protective equipment for fire-fighters:** Fire-fighters should wear appropriate protective equipment and self-contained breathing apparatus (SCBA) with a full face-piece operated in positive pressure mode.
- **Remark:** Do not pressurise, cut, weld, braze, solder, drill, grind or expose containers to heat or sources of ignition.

6. ACCIDENTAL RELEASE MEASURES

- **Personal precautions:** No action shall be taken involving any personal risk or without suitable training. Evacuate surrounding areas. Keep unnecessary and unprotected personnel from entering. Do not touch or walk through spilt material. Put on appropriate personal protective equipment (see section 8).
- **Environmental precautions:** Avoid dispersal of spilt material and runoff and contact with soil, waterways, drains and sewers. Inform the relevant authorities if the product has caused environmental pollution (sewers, waterways, soil or air).
- **Methods for cleaning up:**
- **Small spill:** Move containers from spill area. Vacuum or sweep up material and place in a designated, labelled waste container. Dispose of via a licensed waste disposal contractor.
- **Large spill:** Move containers from spill area. Prevent entry into sewers, water courses, basements or confined areas. Vacuum or sweep up material and place in a designated, labelled waste container. Dispose of via a licensed waste disposal contractor. Note: see section 1 for emergency contact information and section 13 for waste disposal.

7. HANDLING AND STORAGE

- **Handling:** Put on appropriate personal protective equipment (see section 8). Eating, drinking and smoking should be prohibited in areas where this material is handled, stored and processed. Workers should wash hands and face before eating, drinking and smoking.
- **Storage:** Store in accordance with local regulations. Store in original container protected from direct sunlight in a dry, cool and well-ventilated area, away from incompatible materials (see section 10) and food and drink. Keep container tightly closed and sealed until ready for use. Containers that have been opened must be carefully resealed and kept upright to prevent leakage. Do not store in unlabelled containers. Use appropriate containment to avoid environmental contamination.
- **Storage Stability:** The product stability is at least 3 years, when stored in closed containers, at temperatures below +25°C.
- **Recommended Packaging Materials:** Use original container.

8. EXPOSURE CONTROLS/PERSONAL PROTECTION

- **Exposure limit values:**
Ingredient name: No exposure limit value known.
- **Occupational exposure limits:**
Recommended monitoring: If this product contains ingredients with exposure limits, personal, workplace atmosphere or biological monitoring may be required to determine the effectiveness of the ventilation or other control measures and/or the necessity to use respiratory protective equipment. Reference should be made to European Standard EN 689 for methods for the assessment of exposure by inhalation to chemical agents and national guidance documents for methods for the determination of hazardous substances.
- **Exposure controls:**
- **Occupational exposure:** No special ventilation requirements. Good general ventilation should be sufficient to control worker exposure to airborne contaminants. If this product contains ingredients with exposure limits, use process enclosures, local exhaust ventilation or other engineering controls to keep worker exposure below any recommended or statutory limits.
- **Hygiene measures:** Wash hands, forearms and face thoroughly after handling chemical products, before eating, smoking and using lavatory and at the end of the working period. Appropriate techniques should be used to remove potentially contaminated clothing. Wash contaminated clothing before reusing. Ensure that eyewash stations and safety showers are close to the workstation location.
- **Respiratory protection:** Use a properly fitted, air-purifying or air-fed respirator complying with an approved standard if a risk assessment indicates this is necessary. Respirator selection must be based on known or anticipated exposure levels, the hazards of the product and the safe working limits of the selected respirator. Recommended: organic vapour filter.
- **Hand protection:** Chemical-resistant, impervious gloves complying with an approved standard should be worn at all times when handling chemical products if a risk assessment indicates this is necessary.
Recommended: neoprene, nitrile, polyvinyl alcohol (PVA), Viton.
- **Eye protection:** Safety eye wear complying with an approved standard should be used when a risk assessment indicates this is necessary to avoid exposure to liquid splashes, mists or dusts.
- **Skin protection:** Personal protective equipment for the body should be selected based on the task being performed and the risks involved and should be approved by a specialist before handling this product.
- **Environmental exposure controls:** Emissions from ventilation or work process equipment should be checked to ensure they comply with requirements of environmental protection legislation. In some cases, fume scrubbers, filters or engineering modifications to the process equipment will be necessary to reduce emissions to acceptable levels.
